

#### **Certified Defense Financial Manager (CDFM)**

In the U.S., a significant portion of the federal budget is devoted to the defense sector. As a result, the field of defense financial management is both demanding and complex, covering a multitude of interrelated disciplines and intertwined with a highly-developed body of codified fiscal law. The American Society of Military Comptrollers offers the Certified Defense Financial Manager (CDFM) Program to those persons desiring to demonstrate proficiency in the core aspects of defense financial management.

The Certified Defense Financial Manager Program is open to all candidates who have the qualifications shown below. ASMC anticipates that most candidates will be civilian or military members of the Department of Defense, U.S. Coast Guard, or employees of defense contractors and suppliers.

#### The candidate must:

- Adhere to the ASMC Pledge of Professionalism.
- Have a high school diploma or equivalent.
- Successfully complete the required examinations.
- Have completed the required years of financial management experience as follows:
- -Complete three years of defense-related financial management experience (without degree), OR
- -Complete two years of defense-related financial management experience (with an associate degree or higher), OR
- -If no defense related financial management experience, then complete four years of federal government-related financial management experience (with an associate degree or higher).

Candidates may take examinations before completing the required experience; however, certification will not be awarded until all requirements have been satisfied.

#### **ASMC Pledge of Professionalism**

As a CDFM, I will:

- Be guided in all activities by loyalty to the highest principles always remembering that public office is a public trust.
- Refrain from activities which are in conflict with the public interest or are discreditable to the Society, and avoid activities which create the appearance of such conflict.
- Exercise diligence, objectivity and integrity in professional activities, ever aware of the responsibility to eliminate improprieties.
- Refrain from the transmission or usage, for personal gain or advantage, of information obtained in the professional environment.
- Carefully earn and continuously protect my reputation for good moral character in comptrollership.
- · Recognize that professional example will influence associates and
- Recommend and initiate methods to enhance productivity and
- Continuously strive to increase my professional knowledge and skills to improve service and value to associates and the Society.
- Extend the same consideration to the rights and interests of others that I seek for myself.
- · Respect the professionalism of fellow-members and work with them to promote the goals and programs of the Society.

#### **Maintaining Professional Certification**

The names of active CDFMs are listed on the ASMC website, and only active CDFMs may use the designation after their name. All CDFMs must adhere to the ASMC Pledge of Professionalism and meet all renewal requirements to retain the CDFM certification.

CDFMs must renew their certification every 24 months by paying the renewal fee and certifying that they have completed 80 hours of continuing professional education (CPE) in defense financial management topics or related technical subjects (two of the 80 CPEs must be in ethics training), with a minimum of 20 CPEs earned each year. One unit of CPE is awarded for each 50 minutes of contact time engaged in authorized activities. See the ASMC website for detailed guidance on the CPE and CDFM renewal policies.

Certificants are responsible for documenting their own CPE in a log that is readily accessible to the certification holder. A small percentage of certification renewals are randomly selected for CPE audit. ASMC Headquarters will contact those being audited and request the certificant's CPE log and supporting documentation.

CDFMs who are one to 90 days past due for renewal will remain in "active" status with their names appearing on the ASMC website. Individuals over 90 days past the renewal deadline will be placed on "inactive" status and will no longer be shown on the ASMC website as certified. Inactive CDFMs may not display the CDFM certificate or present themselves as CDFMs either in writing or orally.


#### **Reinstatement of Inactive CDFMs**

Inactive CDFMs who qualify for reinstatement must pay the reactivation fee plus the regular renewal fee. See the ASMC website for the full reinstatement policy.

#### **Examination Format**

The CDFM examination series contains four separate modules. Examinations are administered by computer at on-base military education or learning centers and selected commercial testing locations worldwide. Each examination module contains a minimum of 80 multiple-choice questions and candidates are allotted two hours to complete each module.

To achieve CDFM certification, a candidate must successfully complete modules 1-3. The fourth module, Acquisition, is optional. Completion of all four modules will result in the award of the "CDFM-A" (Certified Defense Financial Manager with Acquisition Specialty). Modules may be taken one at a time or all in one sitting and may be completed in any order.

#### **Suggested Methods of Preparation**

ASMC's Enhanced Defense Financial Management Training Course The Department of Defense makes available a one-week Enhanced Defense Financial Management Training Course (EDFMTC) presented by ASMC-approved instructors. The primary purpose of this course is to broaden the students' overall understanding of defense financial management. "Open enrollment" sessions are also available from ASMC licensed providers. Check the ASMC website for course availability.

ASMC's Module 4 Acquisition Business Management Course
ASMC provides a two-day training course emphasizing the Defense
Department's approach to acquisition of major systems. The course
provides an overview of the defense acquisition system, review and
approval procedures, milestones and program management terms.
This course may be helpful in preparing to take the Module 4

Selected elements of the curriculum at these educational institutions, such as the Defense Financial Management and Comptroller School at Maxwell AFB, the Syracuse University Defense Comptrollership Program, the Defense Resource Management Institute and the Naval Postgraduate School, will contribute to preparation for the examinations.

#### **Enrollment**

ASMC members receive a substantial discount on initial enrollment in the CDFM Program. Visit the ASMC website and enroll online. Next steps will be sent via email. Candidates enrolling in the Program have two years to complete their CDFM examination requirements. The candidate can extend the enrollment by submitting an enrollment extension form and paying the appropriate fee.

Due to the changing nature of defense financial management and the need for candidates to demonstrate a full spectrum of knowledge in the field, a reasonable "life of examination" has been established for candidates in the Program. See the ASMC website for the full examination life policy.

#### **Testing**

Computer-based testing is conducted at authorized testing locations worldwide through Pearson VUE's Testing Network or through special arrangement testing.

#### **Americans with Disabilities Act Procedures**

The testing centers located in the U.S. are required to comply with the Americans with Disabilities Act and provide special accommodations. All testing centers are wheelchair accessible, have adjustable height desks, can accommodate requests for readers, and can be adapted to accept special peripheral equipment.

Candidates must identify their need for special accommodations at least five weeks before the desired testing date. ASMC and the candidate will work together to schedule the examination.

## **Notification of Examination Results and Issuance of Certificate**

For computer-based examinations, a message will be displayed on the screen immediately upon completion of your examination showing if you were successful. Once you successfully complete all your exams and meet all eligibility requirements, ASMC will issue you an *award letter* and a CDFM pin. The *award letter* is the official documentation of the CDFM designation. A personalized CDFM certificate will follow within 8-10 weeks of completion of meeting all the CDFM requirements unless you notify ASMC that you intend to also take the fourth module. In that case, the certificate will be held pending completion of all four modules. The Module 4 examination can be taken at any time.

#### **Retaking an Examination**

If you are not successful on an examination, there is no limit on the number of times you may retake that examination. However, there is a mandatory waiting period before each re-examination. The retake fee is the same as the initial fee. See the ASMC website for the current fee structure and examination waiting periods.

#### Rescheduling an Examination

If an examination must be rescheduled for any reason, arrangements must be coordinated through the testing service provider. Please visit the ASMC website for current rescheduling and cancellation policies.
